



## Cyber Security for CEOs

in preparation for NIS2 compliance management

The Network and Information Security directive NIS2 is due to be transposed and applicable on 17 October 2024. In order to strengthen management accountability and prevent cyberattacks, the regulators have mandated the decision maker to be trained in cybersecurity.

This course teaches managers without technical knowledge on NIS2 requirements, state-of-the-art information security management systems, risk management theories and practices, and the technical process for understanding and managing cyber-attacks.
